# Privacy notice

We at Prindit AB respect your privacy and are responsible for the personal data we collect and process about you. Here you will find information about our work with privacy and data protection, including how we collect and use your personal data.

#### Who are Prindit AB?

In this policy, Prindit AB, Orgnr: 559029-3865 is called Prindit and is responsible for personal data. Prindit is responsible for all personal data that you provide in contact with us, which can be on the website, at customer/supplier meetings, via phone, e-mail, chat or when you visit us and participate in networking meetings/seminars. Personal data is information that, individually or in combination with other data, can be used to identify you as a physical individual. It can e.g. be your name, email address or phone number. Our main purpose in processing your personal data is for Prindit to be able to fulfill commitments to you as a customer/supplier, but we also collect information about you who are not yet a customer but whom we intend to contact in order to offer our services. Prindit acts as the personal data controller for the purposes listed in the table further down this page. As a personal data controller, Prindit is responsible for ensuring that your personal data is processed securely and that the GDPR is followed. We do not process sensitive personal data unless there is specific consent to process it.

### Protection of your personal data

Prindit protects your personal data through a combination of technical and organizational solutions. Login and specific authorization are required for access to all of Prindit's systems that handle personal data. Employees at Prindit as well as personal data assistants and assistants must follow Prindit's internal guidelines for data protection.

#### Biträden

#### Tredje land

#### Transfer of information

In order to fulfill some of our purposes, we may disclose your personal data to a third party. Your personal data may be disclosed to the parties described below: To other companies within the group, third parties providing market research services, to authorities, regulatory authorities or courts, to a buyer or a potential future buyer of our business.

#### **Processors**

In some cases, we may use processors who provide services to us, e.g. IT services and security solutions. In these cases, we undertake to have personal Data Processor Agreements (DPA) with all processors and that Processors comply with the data protection regulation (GDPR). All processors must follow our instructions for processing personal data.

#### Third country

Some recipients may be located in countries outside the EU/EEA area. As these countries in some cases have a lower level of protection for personal data than countries within the EU/EEA area, we apply the standard contractual clauses approved by the European Commission when transferring personal data to such countries, to ensure an appropriate level of protection for your personal data. ### Your rights

- You have the right to data portability (the right to have your personal data moved) of personal data that you have provided yourself or that have been generated by your actions/activities.
- You have the right to invoke limitation in the processing of your personal data.
- You have the right to object to the processing of personal data and Prindit will then stop the processing while the matter is investigated.
